3. COMPREHENSIVE PLAN UPDATE DISCUSSION

Also, once a timeline is developed, an expected date of completion should be included in the statement.

- 6. Recreation
- 7. Planned Unit Development (PUD)
- 8. Stormwater
- 9. Proffers

The Planning Commission asked Mr. Morrison what matters are on the horizon and Mr. Morrison listed the following:

- Blue/Green Infrastructure
- Joint Land Use Study (JLUS)
- Market Study (the intent was to help with the Comprehensive Plan update)
- Sub-area plans for the Onley/Onancock area
- Planned Unit Development (PUD) submitted by Atlantic Town Center (ATC)

By the conclusion of the work session, the Planning Commission seemed to agree that a full review of the Comprehensive Plan is needed. Staff was instructed to provide numerous items including, but limited to, demographics and the market study to aid the Planning Commission in its review.
