## 2. New Business

## 2.01 Consider requesting the Circuit Court to issue a Writ of Special Election

Mrs. Burge echoed the comments of Chairman Crockett and expressed her appreciation of the Board of Supervisors waiting until the last possible minute to hold the special meeting, out of respect for Ms. Savage's family.

Mrs. Burge explained that due to the untimely death of Leslie Savage, Commissioner of Revenue for Accomack County, the Board of Supervisors must consider the adoption of the following resolution requesting the Circuit Court to issue a Writ of Special Election to include the position of the Commissioner of Revenue on the Tuesday, November 6, 2018 General Election ballot.

# On a roll-call vote, the Board of Supervisors voted unanimously to adopt:

RESOLUTION OF THE BOARD OF SUPERVISORS OF ACCOMACK COUNTY, VIRGINIA, RELATIVE TO THE UNTIMELY DEATH OF THE COMMISSIONER OF REVENUE, LESLIE SAVAGE

WHEREAS, the Board of Supervisors of Accomack County, Virginia, was notified of the untimely death of the Commissioner of Revenue, Leslie Savage, on July 26, 2018; and

WHEREAS, it is with sadness and a profound appreciation of Commissioner Savage's service to Accomack County's citizens, that a request for the vacancy of the office of Commissioner of Revenue must be filed; and

WHEREAS, a Petition and Writ must be filed in the Circuit Court of Accomack County, Virginia, and the Petition must be accompanied by a Resolution of this Board; and

WHEREAS, The Board of Supervisors of Accomack County finds that an emergency exists for a Writ to be Ordered in time to meet certain deadline requirements; and

WHEREAS, the citizens of Accomack County should enjoy the earliest opportunity to elect a new Commissioner of Revenue and a Special Election held on a short interval would ensure continuity in the office of the Commissioner of Revenue, which is responsible for assessing values for personal property, issuing business licenses, etc. in Accomack County; and

WHEREAS, the Board of Supervisors of Accomack County, Virginia, deems it necessary to enact this Resolution so that all deadlines for an election of a new Commissioner of Revenue may be held at the General Election to be held on Tuesday, November 6, 2018.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF ACCOMACK COUNTY, VIRGINIA, that due to the untimely death of the Commissioner of Revenue, Leslie Savage, it is the desire of this Board to request a Writ of Special Election on Tuesday, November 6, 2018, to elect a new Commissioner of Revenue.

THIS RESOLUTION shall take effect immediately upon its adoption.
