4. NEW BUSINESS (PUBLIC HEARINGS)

A. SUP-2019-002- Nandua Mini Storage, LLC - Tax Map #94-A-116A

The applicant, Mr. Hill of Nandua Mini Storage, LLC, is requesting to amend the Special Use Permit issued on 9/26/88 to expand services to include storage of RVs, boats and trailers pursuant to Accomack County Code Section 106.78(a)(7). The original Special Use Permit, issued to Steve Selby and Robin Lewers, established the business but described it only as a "warehouse storage complex". Mr. Hill purchased the business on November 28, 2018 and has indicated that he hopes to expand in the future with additional storage buildings.

The applicants are proposing to store the vehicles in the graveled area along the fence line nearest the southeastern most storage building (Area 1) and the non-graveled area on the fence side of the shorter building to the north (Area 2). The applicant, in a conversation subsequent to the application, expressed the desire to increase vehicle storage at a rate of ten per year over the next three years, for a total of thirty vehicles.

As motioned by Mrs. Kerns and seconded by Mr. Drewer, the Board of Zoning Appeals moved to approve SUP-2019-002 to amend the Special Use Permit issued on 9/26/88 to expand services to include storage of RVs, boats and trailers pursuant to Accomack County Code Section 106.78(a)(7) with the following conditions:

- A. Apply some surface hardening material to ground, such as shell or gravel
- B. Barricade propane tank to protect against impact
