The monthly Assistant Secretary-Treasurer's report showed an ending balance at April 30 of \$83,859.67. Mr. Murray reminded the Commission of the \$50,000 payment due 7-1-2019 to the Commonwealth of Virginia (*NANDUA* proceeds)

Motion was made by Ms. Major, seconded by Mr. Wolff, that minutes of the meeting of April 2, 2019 be approved. All members were present with the exception of Mr. Fauber and Mr. Coker and voted "yes". The motion was passed.

# STAR Transit Management Report May 7<sup>th</sup> 2019

## **Operations**

- STAR Transit records indicate a fourth consecutive month exceeding ridership totals of the previous year's comparable month. April 2019, STAR Transit provided an impressive 8,432 rides for the residents and guests of the Eastern Shore of Virginia; an increase of 1,087 rides or 12% over April 2018's total of 7345. Additionally, April held the highest one day passenger count recorded; 475 passengers.
- Eastern Shore Community College ridership reports an increase as well, as STAR
  Transit provided 561 rides during the month of April 2019 for current students,
  surpassing April 2018's total of 499.
- An ON / OFF study has been completed, and results will be available for the June ANTDC meeting. This study will assist management and stakeholders identify well

utilized stops within the transit system and will indicate bus stop shelter placement opportunities.

## **Human Resources**

- STAR Transit welcomed one new vehicle operator to the team during the month of April. This driver is currently in training.
- During the month of April, STAR Transit staff conducted annual driving evaluations with all vehicle operators.
- STAR Transit has received the TAPTCO (Transit And Para-Transit Company) training program for use in vehicle operator training. This training program was funded by the Rural Transit Assistance Program at no cost to STAR and covers all aspects of vehicle operation including FTA's drug & alcohol program training.

#### **Marketing and Outreach**

• STAR Transit participated in ESCC's spring break fair on Wednesday April 17<sup>th</sup>, 2019. This was for 9<sup>th</sup> through 12<sup>th</sup> grade students with Disabilities, providing travel training on the use of the STAR Transit system. All attendees were supportive of the STAR Transit, and some inquired about possible northern route extensions.
