9. Old Business

9.1 Consider Award of Emergency Operation Center Construction (Addition to Fire Training Center)

Under Agenda Item 16.1, the Accomack County Board of Supervisors voted to approve budget amendments, which included authorization of the project and award the addition of the Emergencies Operations Center (EOC) to the Fire Training Center to Delmarva Veteran Buildings in the negotiated amount of \$507,400, for the construction and \$82,300 for the generator alternate, for a total amount of \$589,700 and directed the County Administrator to execute a contract.

9.4 Consider Accepting Gift of the existing Accomac Library Property from the E.S. Public Library Board of Trustees pursuant to the terms of the Library Project Memorandum of Understanding (MOU) between the Board of Trustees, Accomack County Board of Supervisors and E.S. Public Library Foundation

On a motion made by Mr. Phillips and seconded by Mr. Muhly, the Accomack County Board of Supervisors voted to accept the deed gift of the existing Accomack Library Property, located at 23610 Front Street in Accomac, VA, from the Eastern Shore Public Library, pursuant to the terms of the Library Project Memorandum of Understanding (MOU) between the Board of Trustees, Accomack County Board of Supervisors, and Eastern Shore Public Library Foundation.

RESOLUTION TO MEMORIALIZE THE FUNDING AND CONSTRUCTION OF THE EASTERN SHORE PUBLIC LIBRARY AND EASTERN SHORE OF VIRGINIA HERITAGE CENTER TO BE LOCATED IN PARKSLEY, VIRGINIA

WHEREAS, on May 16, 2018 the Accomack Board of Supervisors ('County"), the Eastern Shore Public Library Board of Trustees ("Trustees"), and the Eastern Shore Public Library Foundation ("Foundation"), entered into a tri-partite memorandum of understanding ("MOU") to memorialize the understanding and agreement among the parties for the purpose of funding and constructing the Eastern Shore Public Library and the Eastern Shore of Virginia Heritage Center ("Project") in Parksley, Virginia; and

WHEREAS, the terms of this MOU specified the creation of a Library Steering Committee responsible for:

- a) Reviewing and approving a final design for the library project;
- b) Selecting a project manager to oversee day to day operations during construction and to report back to the Library Steering Committee;
- c) Provide monthly state reports to the Trustees, Foundation, and County during the construction period; and
- d) Dissolve itself upon the issuance of a certificate of occupancy, based on the *ad hoc* status of the Steering Committee.

WHEREAS, the Library Steering Committee, since its creation, has worked closely with the Eastern Shore Regional Library's Construction Committee to fulfill its responsibilities under the MOU and has successfully completed items "a" and "b" above, and

WHEREAS, the Trustees has gifted and the Accomack County Board of Supervisors accepted, on September 19, 2018, the following Accomack County Tax Map Parcels, located in Parksley, Virginia, to be the future location of the new Eastern Shore Public Library and Eastern Shore of Virginia Heritage Center:

At a regular monthly meeting of the Accomack County Board of Supervisors, held on the 19th day of June 2019, in the Accomack County Board of Supervisors Chambers, Room 104, in Accomac, Virginia at 5:00 p.m.

WHEREAS, the Trustees has gifted and the Accomack County Board of Supervisors has accepted, on June 19, 2019, the existing Library Parcel, identified as Accomack County Tax Map Parcel 086A20300B00000 located at 23610 Front Street in Accomac, Virginia; and

WHEREAS, the Board of Supervisors has approved the lease of Parcel 086A20300B00000 located at 23610 Front Street in Accomac to the Trustees for consideration of \$1.00 until such time as construction of the Project in Parksley, Virginia, is complete and operations relocated to this location; and

WHEREAS, the Commonwealth of Virginia has committed \$1,500,000 to support the Project; and

WHEREAS, the Foundation has committed \$1,600,000 to support construction of the "Project" comprised of \$850,000 raised from its capital campaign and \$750,000 from loan proceeds which are anticipated to be made available to the Foundation shortly after 6/19/2019, the scheduled date of the Foundation's loan closing, and then immediately transferred to and deposited with the Accomack County Treasurer; and,

WHEREAS, the County has committed \$2,000,000 to support the Project to be obtained through the issuance of bonds and conditional upon satisfactory performance of the terms contained in the tri-partite MOU; and

WHEREAS, the County has conducted a sealed bid process for the purpose of selecting a contractor to construct the Project, and R.H. Contracting, Inc. was determined to be the low bidder for these services; and

WHEREAS, the Library Steering Committee has used the results from the construction bid to finalize design of the Project and has approved a design that, together with all other project costs, bring the total estimated cost of the Project to \$5,100,000 that includes a 6.7% contingency and is within the available funds committed to the Project; and

WHEREAS, Davenport and Company, in their capacity as the County's Financial Advisor, issued on May 31, 2019, a request for proposals for the purpose of obtaining a commercial loan evidenced by a County Lease Revenue Bond, Series 2019, the proceeds of which will be used to fulfill the County's \$2 million funding commitment for the Project; and

WHEREAS, the final major decisions to be considered by the County as prerequisites to commencing construction on the Project are to 1) award and execute the construction contract; 2) award the financing for the County Lease Revenue Bond Series 2019, and 3) execute all related bond documents;

NOW, THEREFORE BE IT RESOLVED, that the Accomack County Board of Supervisors accepts the low bid from R.H. Consulting and authorizes the County Administrator to enter into a construction contract with R.H. Contracting, Inc. in an amount not to exceed \$4,324,479; and

BE IT FURTHER RESOLVED, that the Accomack Board of Supervisors accepts the 3.173% rate option from Sterling National Bank with a term of 20 years and authorizes the Chairman of the Board of Supervisor or County Administrator to execute all bond documents necessary to issue of up to \$2,100,000 in bonds to fulfill the County's \$2,000,000 commitment to the Project and pay for all issuance costs associated with the bond; and

BE IT FURTHER RESOLVED, that neither the construction contract with R.H. Contracting, Inc. or any bond documents shall be executed until such time as the County Administrator receives satisfactory evidence that the County Treasurer has received and deposited the remaining \$750,000 of funds committed to the Project by the Library Foundation and that the Board's determination that the funds have been received shall be evidenced conclusively by the execution and delivery of the construction contract and bond documents.

11.2 Conduct Public Hearing on adjusting the sewer rate for the Central Accomack Service Area from \$21.70 per thousand gallons to \$22.57 per thousand gallons.

Mr. Stewart Hall, Deputy Director of Public Works & Facilities explained to the Board that in accordance with the agreement with the Town of Onancock, the County is charged with the lowest Town rate within the Town's tiered fee structure for wastewater that is conveyed from the County's Central Accomack Sewer System to the Town's system for treatment. The Town of Onancock's approved FY20 budget contains 4% rate increase applicable to all wastewater rate tiers, meaning the amount the County pays to the Town for treatment services will increase.

Chairman Hart opened and closed the Public Hearing; no one signed up or wished to speak.

On a motion made by Mr. Crockett and seconded by Ms. Gordy, the Accomack County Board of Supervisors voted to pass the rate increase of 4% (\$21.70 per thousand gallons to \$22.57 per thousand gallons), implemented by the Town of Onancock for water treatment services, to the end users of the County's Central Accomack Sewer System.

13.3 Re-painting of Navy A-4 Jet at County Airport

Mr. Mason informed the Board that County Airport Manager, Barbara Haxter, through her connections with a local retired Navy pilot, reached out to an aircraft maintenance group at Naval Air Station Oceana regarding the painting of the Navy A-4 jet that adorns the County Airport property. The outcome of this discussion is that this group is willing to re-paint the aircraft on-site. They even supply the paint which will be their current squadron colors. The expectation is the work will take about a week and the only cost to the County will be for housing accommodations while they are here. Approval from the Navy museum contact in Pensacola, who the County has the asset loan agreement with, has been obtained. He also remind the Board that repainting and maintenance to this A-4 has previously been estimated at \$50,000, expressing that this is a very cost effective solution.
