STAR Transit Management Report December 3rd 2019

Operations

- STAR Transit's ridership totals for the month of November 2019 indicate a decrease in passenger count compared to November of 2018. This decrease was expected as expansion efforts and streamlining of the STAR Transit service schedule November 1st eliminated the need for a mandatory transfer HUB in Parksley Va.
- Eastern Shore Community College ridership is up from last year. In the month of November 2019 STAR Transit provided 528 rides to ESCC students compared to November 2018's total of 486 student rides provided.
- The Accomack On-Demand "Green" route is experiencing an unprecedented amount of cancellations and no-shows. During the month of December, these inconveniences will be tracked, and passengers will be contacted regarding On-Demand guidelines.

Human Resources

• STAR Transit continues its efforts to recruit an additional vehicle operator.

Marketing and Outreach

- New Map & Schedules have been distributed throughout the entire STAR Transit service area. The new route schedules and additional service provided on the Blue / Gold routes are well liked by our passengers.
- The Blue / Gold expansions as well as the new Silver Loop expansion routes which began November 4th 2019 are performing above expectations.
- STAR Transit management will be meeting with Perdue and Tyson's human resources departments during the month of December. Tyson's has started an 8am shift, and STAR Transit is pleased to report an increase in route utilization to that destination.

• STAR Transit did not have any scheduled training for the month of November 2019, rather focused efforts toward the new schedules and operations north of Onley Va. to ensure safety and timeliness thereof.

Mr. Jim Outland, General Manager of Canonie Atlantic, Mr. Jim Outland, submitted the following activities report for November:

Canonie Atlantic Company General Manager's Report 12/3/2019 <u>Need CAC Board Approval – CAC Signature Authority</u> - Created a draft CAC Signature Authority for Board review; also need to confirm who the CAC Board Members are that will be signers.

Need CAC Board Approval – Temporary Cart Crossing – Created a draft construction and rental agreement for a temporary golf cart crossing of the Cape Charles rail yard. Agreement specifies no crossing is to be installed until full liability is assumed by an entity other than CAC. I have also spoken with CAC's insurance representative regarding the temporary golf cart crossing and have provided her with pictures as well as the proposed path route. She is consulting with the underwriter regrading this.

<u>Need CAC Board Approval – CCBC Lease</u> - Created a draft lease agreement with Cape Charles Brewing Company to lease space for three historic rail cars.

<u>Need CAC Board Approval -Painter Culverts Cleanout</u> – met with members of Accomack Co.'s ditch maintenance team regarding two obstructed CAC culverts in the Painter area that are contributing to significant residential and Route 13 flooding during periods of heavy rain. I've engaged with a vendor and have a quote for \$4400.00 to complete the work.

Mowing of the Cape Charles Rail Yard completed in early November.

Have also had a yard walk through with a scrap vendor regarding continued yard cleanup starting in January. The same scrapper will also scrap a cement car at Little Creek (working with BBRR on this).

I have posted Posted – No Trespassing signs throughout the Cape Charles yard to better highlight the status of the property for tourists, townspeople and town employees.

NEW BUSINESS

In Re: Resolution – Rails to Trails Project

Motion was made by Mr. Murray, seconded by Mr. Coker, that the following resolution be adopted. All members were present with the exceptions of Mr. Wolff and Ms. Major and voted "yes." The motion was unanimously passed. Said resolution as adopted is set forth below:

RESOLUTION APPROVING CONVERSION AND DEVELOPMENT OF CANONIE ATLANTIC COMPANY'S 49.1 MILES OF RAILROAD CORRIDOR TO AN EASTERN SHORE RAIL-TO-TRAIL PROJECT

- **WHEREAS,** the counties of Accomack and Northampton are the principal members of the Accomack-Northampton Transportation District Commission Board; and
- **WHEREAS**, the Accomack-Northampton Transportation District Commission Board is the sole shareholder of Canonie Atlantic Company; and
- **WHEREAS,** Canonie Atlantic Company is a private entity which owns 49.1 miles of railroad corridor located in Accomack and Northampton Counties commonly called the Eastern Shore Railroad (ESHR); and
- **WHEREAS,** Canonie Atlantic Company filed a petition with the Surface Transportation Board to discontinue service and end its common carrier obligation to provide freight rail service over the approximately 49.1 miles of rail line in Accomack and Northampton Counties; and
- **WHEREAS**, the Surface Transportation Board decided on October 31, 2019 to approve Canonie Atlantic Company's petition for abandonment of service.
- **NOW, THEREFORE, BE IT RESOLVED,** that the Accomack-Northampton Transportation District Commission approves moving forward with the conversion of the Canonie Atlantic Company's 49.1 miles of abandoned rail line to a rails-to-trails corridor; and
- **BE IT FURTHER RESOLVED**, that it is agreed to seek the support of all appropriate governmental agencies within the Commonwealth of Virginia to achieve the goal of development of a rails-to-trails facility; and
- **BE IT FURTHER RESOLVED,** as the Dahlgren Railroad Heritage Trail Association with support from the Virginia Bicycling Federation has petitioned the Surface Transportation Board to approve a Certificate or Notice of Interim Trail Use to work with the Accomack-Northampton Transportation District Commission, Canonie Atlantic Company, and the Counties of Accomack and Northampton, it is in the best interest of the Accomack-Northampton Transportation District Commission to negotiate with the Dahlgren Railroad Heritage Trail Association as a step in achieving its overarching goal of developing a world-class Eastern Shore Rail-to-Trail.
- **NOW, THEREFORE, BE IT RESOLVED** that the Accomack-Northampton Transportation District Commission approves proceeding with the conversion of the Eastern Shore Railroad to a Rails-To-Trails project, and seeks the support and assistance of the Commonwealth of Virginia and the Dahlgren Railroad Heritage Trail Association and the Virginia Bicycle Federation in the successful development and completion of this project.

NOW, THEREFORE, BE IT RESOLVED, that the Accomack-Northampton Transportation District Commission does hereby recognize and applaud the long-time, faithful and outstanding service by Mr. H. Spencer Murray during his tenure of service and furthermore does hereby extend its best wishes to him and his family for their future success and happiness.
