Janet Martin Turner – Onancock– 27 public water accesses and often the Folly Creek ramp is left with litter and the majority of those using the facilities is out of state people and believes there should be a charge for those out of state to share in the cost of upkeep at the facilities. Requested that the Board consider a decal system. She does not believe this will impact our small businesses as most come with coolers packed and leave in the evening. Provided the Board with a chart of boat ramps and fees.

B. Gary Stuff – Temperanceville – expressed that in Gargatha and Folly Creek, most fishermen are from out of state and are the primary offenders of littering and should share in the cost of upkeep at the boat ramps.

Board members noted that while there were only two speakers, many had received emails and phone calls from citizens within their district also expressed the need to charge for the use of the boat ramp to maintain facilities. Mr. Mason responded that he and staff had begun researching the possibilities.

Watermen Grant

- The Watermen Grant Application was opened on June 15th at 10:00 a.m. and closed June 17th at 5:00 p.m.
- 40 applications were received within the first 45 minutes
- 83 applications were received in total.
- The recipients were notified by email on June 22nd, and recipients were informed we needed a W-9 back in order for them to receive payment.

Small Business Grant

- The Small Business Grant Application was opened on July 6th at 10:00 a.m. and closed July 10th at 5:00 p.m.

- Staff is currently reviewing the applications for eligibility.

- The review of applications has been more complicated than expected.

Mr. Mason informed the Board that effective July 1, 2020, executive directors and members of economic development authorities and industrial development authorities are required to submit a Statement of Economic Interest (SOEI) form with the clerk of the local governing body. This new requirement mandates that this first submission is due no later than August 1; however, because August 1 falls on a Saturday, the deadline thereby automatically moves to the next business day, Monday, August 3, 2020. He advised that staff had also notified the EDA.

10.2 Conduct Public Hearing on proposed DHCD Urgent Needs Grant Application

Ms. Bobbie Jo Wert, A-NPDC, informed the Board that the Virginia Department of Housing and Community Development (DHCD) is making available current CDBG funding to small cities, towns, and rural counties to respond to local needs related to COVID-19 response.

The Community Development Block Grant (CDBG) program will assist units of local government and communities in response to the health and economic impact of COVID-19 by supporting planning grant, open submission, and urgent need recovery activities.

Eligible Activities

- Construction or rehab of structures to be used for shelters, testing, or equipment manufacturing
- Training programs for healthcare workers or service industry jobs transitioning to food/pharmaceutical delivery systems
- Acquisition costs for telework/telemedicine services
- Job creation or business development for manufacturing of COVID-related materials, supplies, or equipment (PPE)

The A-NPDC is administering the grant and has contacted community service providers in order to compile a list of COVID-19 urgent needs within the County. The complete list of projects (attached) totals almost \$10M but the maximum available grant is \$1M total/\$800,000 max for facilities. The County will have to prioritize needs with the first level of prioritization devoted to ensuring proposed projects meet the eligibility requirements of the program. Ms. Wert informed the Board that a list of eligible budget requests from community partners was included within the Board's agenda packet.

Mr. Mason noted that the grant required two public hearings be held prior to submission of the grant to DHCD. This is the first public hearing, to gauge which projects the public finds the most important; no action is necessary until after the 2nd public hearing.

Ms. Major opened and closed the public hearing as no one signed-up or wished to speak.
