Eastern Shore CPMT Meeting

CPMT Chair, Vicki Weakley called the ES CPMT meeting to order at 1:57 PM on June 2, 2022 at the Accomack County DSS, in Accomac, Virginia. Present were, Jennifer Annis, Terra Custis, Kathy Lewis, Mozella Francis, Nadj Plowden, Marcus Riley, Mimi Sedjat and Rudy Zavala.

On a motion per Jennifer Annis and seconded by Kathy Lewis CPMT approved the minutes from May 5, 2022 and May 13, 2022 with the corrections of revising emergency meeting minutes from 5/13/22, capturing that Rudy Zavala made the second motion to adjourn the emergency meeting.

There were no case reviews or funding approvals for this CPMT meeting.

New Business:

- CPMT discussed the interagency collaboration and warm transfer process for referring cases to CSA. CPMT had a consensus agreement that, if needed, an interagency collaboration team meeting would take place for case assignments for referrals.
- CPMT reviewed CQI data for FY 22 ESCSA program. CPMT reviewed and
 discussed demographics and child count by service placement type. During its
 review CPMT had a consensus agreement that CPMT would continue to analyze
 data and characteristics that have changed in the community that may have
 impacted CSA referrals. CPMT decided that by September 2022, they would
 create a survey that would focus on questions that would assist with data
 analysis to share with its partners and stakeholders in the community whom
 make referrals to CSA.
- The CSA Coordinator provided CPMT with updates pertaining to the FY 2021-2022 OCS state audit. The CSA Coordinator shared that he did meet with the OCS auditor on 5/12/22 and was informed that the auditing process is still ongoing as there were a few localities ahead of the Eastern Shore. The CSA coordinator shared speculations of when the final stages of the audit would take place in order to ensure all details are covered and the appropriate trainings would be developed to continue to support the success of the Eastern Shore CSA program.
- The CSA coordinator also provided CPMT with updates pertaining to Medicaid budget impacts on CSA for FY 23. The increase of 12.5% for community based behavioral health services would go into effect by July 1, 2022 pending governor approval.
- The CSA coordinator also informed CPMT of the Virginia Private Day Special Education rate study implementation trainings sponsored by Public Consulting

group. The information on how to join these two virtual trainings, scheduled for 6/17/22 and 6/29/22, was provided.

With no further business to discuss Marcus Riley motioned to adjourn and Kathy Lewis seconded the motion. The Eastern Shore CPMT adjourned at 4:08 pm. The next regularly scheduled CPMT is July 7, 2022 at the Accomack County DSS in Accomac, Virginia.
