The monthly Assistant Secretary-Treasurer's report showed an ending balance at February 28th of \$69,446.69.

In Re: Minutes of February 7, 2023

Operations

• STAR Transit's operation continues to provide strong ridership results. Last month was an example of the third best February on record.

Human Resources

- STAR Transit continues to recruit for vehicle operators throughout the Eastern Shore service area.
- Annual Vehicle Operator performance evaluations have been completed. These
 evaluations include observation of the driver's pre-trip inspections, vehicle operation,
 ADA passenger securement, client relations, trip sheet utilization, communications
 and schedule adherence.

Marketing and Outreach

 STAR Transit has been in conversations with representatives from the Town of Onancock, Onancock Senior Living and Commonwealth Senior Living Center regarding their desire for public transportation service in and around their local area. Conversations will continue throughout the month of March, and updates to the ANTDC will be provided.

• STAR Transit representatives presented transit service information to the County of Northampton and to the County of Accomack Boards of Supervisors in February. This information was delivered in relation to STAR Transit's local match requests for FY24 funding.

Training

No trainings were scheduled or held during the month of February.

Transit Capital and Infrastructure

- STAR Transit has ordered one (1) 20 passenger body on chassis bus to replace unit #42 which has reached the end of its useful life as defined by the FTA. This purchase is being made using funds from capital grant # 42023-29. Originally this grant was to replace 3 of STAR Transit's buses, (42, 43 and 45) but due to substantial and unforeseen cost increases, two buses were pulled from this grant and are requested in FY24 for replacement. Additional orders will be placed in the month of March.
- A Request for Quotes has been issued on STAR Transit's website and will be posted in local papers for the repair and modification of the facility's storm water retention pond. Quotes must be received by COB April 17th.
- The Department of Rail and Public Transportation has selected STAR Transit as one of several transit systems to participate in a flex GTFS feed project for both fixed route and on-demand services. This project will assist in mapping, trip planning and promotion of transit routes and service areas through State supported programming. There is no cost to STAR Transit to participate in this project.

In Re: State's Comments

Ms. Balderson said that the Department was working on the Six Year Program. In furtherance to the STAR Transit bus acquisition, Ms. Balderson said that many agencies statewide have had to downgrade their bus orders due to supply and cost issues. Applications in excess of \$40M have been received under the Rail Preservation Program and a record number of applications have been received under the Industrial Rail Access Program.

Mr. Wolff said that Rocket Lab's second launch of its electron rocket is planned for March 11th with simultaneous events at Wallops and New Zealand.

Mr. Camden of Buckingham Branch Railroad said that there was "lots of activity" in Little Creek. Mr. Rosner of DCR said that propane shipments were slow due to the warmer weather.

In Re: VDOT Report

Mr. Chris Isdell, Residency Administrator, noted that the Accomack County Rt. 13 asphalt paving contract will begin in 1-2 weeks and will be completed by summer. Northampton's Rt. 13 paving contract bids were over-budget and will be re-issued. The bids for the Route 602 (Cemetery Road) project which spans both counties came in higher than anticipated. VDOT is looking to retrim the scope of work and will most likely be rebid. Only one response was received. The Commonwealth Transportation Board's public hearing on the bike trail will be held on March 13th.

In response to a question from Canonie President Spencer Murray, Mr. Isdell said that the signs and signals at the Route 13 crossing have been removed; however, the pavement markings still remain. The signage on the secondary road crossing locations is also being removed.
