BZA Ruling on poultry houses located on Savageville Road. Ms. Riggs submitted her written comments.

2. **Justin Nick** – Savageville Road, Melfa

Pastor of Gaskins Methodist Church on Savageville Road, which was established over 150 years ago. Church members and residents remember the poultry operation being operated and the manure shed fire which smoldered for many weeks. Requested that the Board take action on the ruling of the BZA decision regarding the poultry houses on Savageville Road.

Mr. Hart stated that Savageville Road is a large portion of District 8. While BZA members are appointed by the Circuit Court judge and do not have oversight, this will have a major impact on the Savageville neighborhood. Requested that staff review this project and mediate the situation, if possible. He reminded the Board that the majority of poultry houses are in the southern in of the County and in minority residential communities, which looks bad and is concerning. Staff will research and return to the Board with a report.

Ms. Proctor informed the Board that it has no jurisdiction over the BZA and the appeal process is through the Circuit Court, but the Board can attempt to mediate the situation between the poultry operation and residents.

Chairman Crockett discussed the Ordinance with Mr. Mason and the lack of historical permits. Mr. Wolff noted that the County already has a Noise Ordinance in place that is enforceable by Law Enforcement.

8.4 Conduct Public Hearing on revisions to Chapter 38 Regarding Agreement in Lieu Plans and Farm Structures

Mr. Lee Pambid, Deputy County Administrator – Building, Planning, and Economic Development reviewed the request.

Chairman Crockett opened and closed the public hearing as no one signed up or wished to speak.

On a motion made by Mr. Wolff and seconded by Mr. J. Phillips, the Accomack County Board of Supervisors voted to approve the following revisions to Chapter 38 Regarding Agreement in Lieu Plans and Farm Structures.

9. New Business

- 9.1 Consider directing the County Administrator to Assign County Staff to Create, Compile and Provide information to be used by Tasley and Bloxom Volunteer Fire Departments to Justify the Relocation of two Bloxom VFD Ambulances to the Tasley Firehouse and to support their request for the County to provide staff to operate these ambulances
 - Mr. Glenn Smith, a representative of the Tasley Volunteer Fire Company presented to the Board.
- 9.2 Mrs. Margaret Lindsey, Director of Finance, gave a presentation reviewing the County's Fourth Quarter FY 23 financial report unaudited.
- 9.3 Mr. Jeremy Shifflett, Deputy Director of Public Works & Facilities, reviewed the requested amendments to the Accomack County Procurement Policy to allow Job Order Contracting.

On a motion made by Mr. Hart and seconded by J. Phillips, the Accomack County Board of Supervisors voted to approve the following amendments to the Accomack County Procurement Policy, as was presented:

ARTICLE XIII. Job Order Contracting.

- A. A job order contract may be awarded for multiple jobs, provided (i) the jobs require similar experience and expertise, (ii) the nature of the jobs is clearly identified in the solicitation, and (iii) the contract is limited to a term of one year or when the cumulative total project fees reach the maximum authorized in this section, whichever occurs first. Contractors may be selected through either competitive sealed bidding or competitive negotiation, provided that any job order contract that involves construction shall be procured by Competitive Sealed Bidding unless one or more of the exemptions in Virginia Code §2.2-4303 applies.
- B. Such contracts may be renewable for two additional one-year terms at the option of the public body. The fair and reasonable prices as negotiated shall be used in determining the cost of each job performed, and the sum of all jobs performed in a one-year contract term shall not exceed the maximum threshold amount. The maximum threshold amount shall be \$6 million. Subject to the maximum threshold amount, no individual job order shall exceed \$500,000.
- C. For the purposes of this section, any unused amounts from one contract term shall not be carried forward to any additional term.
- D. Order splitting with the intent of keeping a job order under the maximum dollar amounts prescribed in subsection B is prohibited.
- E. No job order, under a job order contract, shall be used solely for the purpose of receiving professional architectural or engineering services that constitute the practice of architecture or the practice of engineering as those terms are defined in Virginia Code § 54.1-400. However, professional architectural or engineering services may be included on a job order where such professional services (i) are incidental and directly related to the job, (ii) do not exceed \$25,000 per job order, and (iii) do not exceed \$75,000 per contract term.
- F. Job order contracting shall not be used for construction, maintenance, or asset management services for a highway, bridge, tunnel, or overpass. However, job order contracting may be used for safety improvements or traffic calming measures for individual job orders up to \$250,000, subject to the maximum annual threshold amount established in this section.

9.4 Consider accepting FAA and DOAV grants for the Airport Runway 2-1 Turnaround Construction Project

On a motion made by Mr. Hart and seconded by Mr. Wolff, the Accomack County Board of Supervisors voted to accept the following grants for the Airport Runway 2-1 Construction Project:

- A. FAA (AIG) grant in the amount of \$304,000; DOAV (State) grant in the amount of \$109,168. Further, move to allocate an additional \$16,292 from the Airport Enterprise Fund Balance to supplement the local matching funding and authorize staff to execute the necessary documents associated with these grants.
- B. FAA (AIP) grant in the amount of \$924,140 has been awarded but is subject to a public hearing before the Board may accept and appropriate these funds.

10. County Administrator's Report

- 10.1 Status Update: Employee Compensation and Classification Study
- 10.2 Status Update: Recommendation regarding whether to approve the dissolution of Eastern Shore Resource Conservation and Development Council as requested by the Council

Mr. Mason stated that at the Board's direction in August, he began reaching out to Legal Sponsors of the ESRC&D. Since, the ESRC&D submitted a revised request, requesting the County assign a representative to meet with the Council.

Board consensus was to appoint Mr. Mason as its representative and the Board's intent is to proceed with dissolving the Eastern Shore Resource Conservation and Development Council.

- 10.3 Status Update: Recommendation regarding whether to allow construction of PVFD substation on County-owned property located at Fishers Corner
 - Staff, PVFC representatives, and VDOT met on-site to discuss the proposed project, but at the moment, staff is unable to make a recommendation.

- 10.5 VDOT Speed Study Response: Fleming Road Speed reduction not recommended

Mr. Muhly visited Captain's Cove last weekend and noticed a 25-mph speed limit at Dublin Farms and in the opposite direction it stated the end of the 40-mph speed limit, following the VDOT report that the speed limit would not be lowered. *Staff agreed to report the issue to VDOT*.
