Motion was made by Mr. Bennett, seconded by Mr. Smith, that Mr. Coker, Mr. Sturgis and Ms. Major be reappointed for new three-year terms on the Eastern Shore Rail Trail Foundation, commencing April 1, 2024 and that the following resolution be adopted therefor. Motion was made by Ms. Major, seconded by Mr. Coker, that Mr. Jim McGowan be appointed to the Rail Trail Foundation, to fill Mr. Bennett's remaining term. All members were present with the exception of Ms. Balderson and voted "yes." The motion was unanimously passed.

# **Operations**

• February 2024 ridership totals remain strong, providing 8,409 rides during the month to residents and guests of the Eastern Shore of Virginia.

## **Human Resources**

- STAR Transit has successfully assisted its third ELDT program participant in obtaining their CDL with passenger endorsement. This program and capability to train drivers toward licensure has been beneficial for the STAR Transit organization and for the community as a whole as a workforce development tool.
- A fourth ELDT candidate has entered STAR Transit's training program toward licensure.

# **Marketing and Outreach**

- STAR Transit representatives presented operational and financial information to the Accomack County Board of Supervisors on February 8<sup>th</sup> and to the Northampton County Board of Supervisors on February 27<sup>th</sup>. All discussion at both hearings were in relation for STAR Transit's FY25 local match requests.
- Route evaluations are underway to assist in STAR Transit's annual route map timing and path adjustments. Changes are safety focused to ensure routes have adequate time for travel and utilize safe crossing and stop locations.

## **Training**

• All STAR Transit vehicle operators have completed their annual Drug and Alcohol Training as required by the STAR Transit D&A Policy. In addition to this, STAR Transits leadership team holds up to date certifications in reasonable suspicion as required by FTA.

# **Transit Capital and Infrastructure**

- STAR Transit's Capital Grant project #42023-31 for the installation of a "standby generator" has been completed during the month of February.
- STAR Transit's Capital Grant project #42023-32 "Phase 1" for the repairs and modifications of the storm-water retention pond have been completed during the month of February. A capital application for "phase 2" was provided to DRPT in January 2024 with the hopes of approval by the CTB for July 2024 funding.

• STAR Transit's Capital Grant project #42022-49 "Perimeter Chain Link Fence" RFQ was advertised in February 2024. Multiple quotes have been received and are being evaluated at this time. This grant has an expiration of Sept 30 2024.

## In Re: VDOT Report

Mr. Chris Isdell, Residency Administrator of VDOT provided an overview of upcoming projects in both counties and also noted that the mowing contracts have been awarded. He further noted some erosion concerns with both the Saxis and Chincoteague causeways.

On another VDOT matter, staff noted that a survey has been received to evaluate the environmental impacts of the Rail Trail. The Commission reviewed the proposed answers to the survey and approved its submission as presented.

## In Re: Elect Representative & Provide Instructions for the Canonie Atlantic Co. Annual Meeting

## In Re: Application for SS4A Grant

As referenced earlier in the Eastern Shore Rail Trail Foundation meeting, Tim Lewis of the FHWA has suggested that an application be made for a SS4A (Safe Streets for All) grant to convert some Rt 13 crossings into pedestrian crossings. The initial grant request would be for a safety study for both counties which requires a 20% match. The study is estimated to cost \$200,000. Motion was made by Ms. Major, seconded by Mr. Bennett, that the ANTDC approve and support the ANPDC applying for the SS4A grant. All members were present with the exception of Ms. Balderson and voted "yes." The motion was unanimously passed.

In Re: Approval of Quitclaim Deed for Property Conveyance from The Conservation Fund

Motion was made by Mr. Coker, seconded by Ms. Major, that the Quitclaim Deed between the ANTDC and Canonie Atlantic Co. for the real property identified as a portion of Tax Map 54-A-29 located on Mears Station Road, Accomack County, Virginia, be approved and that the Chairman be authorized to execute any and all documentation relating to this real property conveyance. All members were present with the exception of Ms. Balderson and voted "yes." The motion was unanimously passed.
