2.1 Receive County Administrator's FY25 Proposed Budget

County Administrator, Mike Mason, provided a thorough overview <u>presentation</u> of the proposed Fiscal Year 2025 Budget and key priorities. There was discussion and questions from Supervisors.

The Board expressed its support of Mr. Mason's proposals to develop a plan that addresses the County's needs in a fiscally responsible manner. Mr. Mason explained that decisions needed to be made on specific budget allocations at this initial presentation meeting. Mr. Mason stated that staff would advertise a public hearing on the proposed budget for March 5<sup>th</sup> and tentatively schedule a public hearing on the proposed budget around March 25<sup>th</sup>, aiming to adopt the final FY2025 budget by April 1<sup>st</sup>.
