In Re: Call to Order

The Chairman called the meeting to order and indicated that a quorum was present.

In Re: Invocation

The invocation was given by Mr. Wolff.

In Re: Statements from the Public

In response to a question posed last month by Mr. Bennett, Mr. Jackie Phillips said that the ditch "spider" was surplussed and sold by Accomack County. At this time, Accomack has no employees in the ditch maintenance department and any future maintenance needs will be contracted out. Mr. Bennett replied that it would be really good if both counties could acquire a spider jointly; per Mr. Phillips they cost \$350,000 - \$375,000.

In Re: Account Balances

The monthly Assistant Secretary-Treasurer's report showed an ending balance at March 31 of \$70,650.60.

In Re: Minutes of March 5, 2024.

Motion was made by Ms. Major, seconded by Mr. Bennett, that the minutes of the meeting of March 5, 2024, be approved as presented. All members were present with the exception of Ms. Balderson and voted "yes." The motion was unanimously passed.

Operations

• Due to the timing of month end, March 2024 ridership totals will be announced at the April 2nd meeting.

Human Resources

• STAR Transit has two employees entering the ELDT program with hopes of obtaining their CDL with passenger endorsement.

Marketing and Outreach

- Route evaluations have continued throughout the month of March to assist in STAR Transit's annual route map timing and path adjustments. Changes are safety focused to ensure routes have adequate time for travel and utilize safe crossing and stop locations.
- During the month of March, the Accomack and Northampton Community Service Board's had advertisements applied to the rear of 3 different STAR Transit buses.

Training

- March training for STAR Transit vehicle operators was centered on LLLC defensive driving, adverse driving conditions and pre-trip and post-trip inspection requirements.
- Additional training during the month provided to vehicle operators were ADA Compliance and vehicle security.

Transit Capital and Infrastructure

- STAR Transit's Capital Grant project #42023-31 for the installation of a "standby generator" has been completed during the month of February. Unfortunately the generator has a defective circuit board. A replacement board has been ordered for this unit and should arrive soon. Until the unit is operational, this grant project will remain open and the invoice held.
- STAR Transit's Capital Grant project #42022-49 "Perimeter Chain Link Fence" RFQ was advertised in February 2024. Quotes have been reviewed and one proposal is identified as a potential for contract negotiations.
- During the month of March, three new Ford Starcraft Allstar buses were introduced to passenger service on the Eastern Shore. One has been returned to a local dealership for warranty related engine repairs.

NEW BUSINESS

In Re: Resolution for Memorial Monument

Motion was made by Mr. Coker, seconded by Mr. Sturgis, that the following resolution be adopted to support the placement of a Memorial Monument near Nassawadox, recognizing Mr. Arthur "Big Boy" Crudup. All members were present with the exception of Ms. Balderson and voted "yes." The motion was unanimously passed. Said resolution as adopted is set forth below:

RESOLUTION

WHEREAS, Mr. Arthur "Big Boy" Crudup, a blues singer, guitarist, and songwriter sometimes called "The Father of Rock 'n' Roll" lived in Franktown, Virginia; and

WHEREAS, he toured internationally and performed with his sons James, George and Jonas as "The Malibus" in Weirwood and Nassawadox and died on March 28, 1974, and is buried near Nassawadox; and

WHEREAS, the Virginia Department of Historic Resources has decided to create an historic monument for Arthur Crudup and would like to place it, possibly within the right-of-way owned by Canonie Atlantic Co., in the Town of Nassawadox in Northampton County; and

WHEREAS, the Town Council of Nassawadox recently approved a Resolution agreeing to the placement of the aforementioned monument in their Town.

NOW, THEREFORE, BE IT RESOLVED, that the Accomack-Northampton Transportation District Commission hereby supports and approves the placement of the Arthur Crudup Memorial Monument in the Town of Nassawadox within the right-of-way owned by Canonie Atlantic Co.
