# **Accomack County EMS Response Plan**

### SCOPE

The Accomack County Emergency Medical (EMS) Response Plan is required by the Office of Emergency Medical Services, a Division of the Virginia Department of Health, Virginia Emergency Medical Regulations 12VACS-31-610. "Designated Emergency Medical Response Agency Standards"

Accomack County has established *primary service areas* for Emergency Medical Response and *responding interval standards* for all EMS agencies providing pre-hospital emergency medical care and transport in the County.

The *primary service area* for each EMS agency is the specific geographic area designated or prescribed by the county in which an EMS agency provides pre-hospital emergency medical care and transportation. Such areas are defined within an EMS district for each EMS agency, and all locations identified within this designated or prescribed geographic area are those in which the EMS agency shall be principally dispatched as the first due EMS response agency. EMS districts along with existing deployment models will periodically be reviewed and refined to ensure that designated or prescribed geographic areas receive the timeliest and most appropriate patient care available.


### CONTENT

Accomack County is bounded on the east by the Atlantic Ocean and on the west by the Chesapeake Bay. Responses may include entering into these two bodies of water, with the assistance of the United States Coast Guard, Virginia Marine Resources, Virginia Game Commission and or other agencies.

#### RESPONDING INTERVAL STANDARDS

Turnout Time - Elapsed time in minutes between the Dispatch Notified Time and the responding unit En-Route time

✓ Staffed Unit "4 minutes or less 90%"
✓ Un-Staffed Unit "8 minutes or less 90%"
✓ System Performance "6 minutes or less 90%"

Response Time- Elapsed time in minutes between the Dispatch Notified Time and the first

responding unit arriving On-Scene

✓ Staffed Unit "20 minutes or less 90%"
✓ Un-Staffed Unit "20 minutes or less 90%"
✓ System "20 minutes or less 90%"

If the designated emergency response agency finds it is unable to respond within the established unit mobilization interval standard, the call shall be referred to the closest available mutual aid EMS agency.

If the designated emergency response agency finds it is able to respond to the patient location sooner than the mutual aid EMS agency, the EMS agency shall notify the PSAP of its availability to respond.

If the designated emergency response agency determines in advance that it will be unable to respond for emergency service for a specified period of time, it shall notify its PSAP.

### **DOCUMENTATION OF COMPLIANCE**

Each agency with a designated Primary Service Area is responsible for the review and compliance of established EMS response interval standards. The results of this review will be provided to the County's Operational Medical Director and the Accomack County Board of Supervisors for analysis.
