## A. June 10, 2014

On a motion made by Mr. Edwards and seconded by Mr. Seybolt, the Economic Development Authority voted to not participate this year in either the membership or advertisement with the Chincoteague Chamber of Commerce.

On a motion made by Ms. Ashby-Hope and seconded by Ms. Zamora, the Economic Development Authority voted to approve the Treasurers report as presented.

Mr. Bloxom reported that there is now a drone runway in the budget for a research testing site at Wallops Island.
