#### 5. PRESENTATION

# A. FEMA Flood Maps

Mr. Morrison introduced David Fluhart, the Building and Zoning Director for Accomack County, to the Planning Commission.

Mr. Fluhart presented a PowerPoint presentation to the Planning Commission on the proposed Federal Emergency Management Agency (FEMA) flood maps.

On a motion made by Mr. Silverman and seconded by Mr. Corazza, the Planning Commission voted to schedule a public hearing on the Planned Unit Development District Regulations for October 8, 2014.

#### 7. 7:30 P.M. PUBLIC HEARING

## A. Atlantic Town Center Development Corporation Conditional Rezoning

Staff announced that correspondence was received from Joan Kean of Chincoteague regarding the Atlantic Town Center Development Corporation Conditional Rezoning public hearing. Ms. Tremblay, Assistant Planner, read Ms. Kean's letter into the record. [A copy of Ms. Kean's letter may be obtained from the Planning and Community Development Department.]

At 7:30 p.m., Chairman Lumgair opened the public hearing.

Mr. Morrison presented a PowerPoint presentation on the Atlantic Town Center Development Corporation conditional rezoning request.

Chairman Lumgair opened the floor for the applicant's attorney, Mark Baumgartner, to present a PowerPoint presentation.

During his presentation, Mr. Baumgartner distributed a "Spreading Cost Maximizes Affordability" handout to the Planning Commission, a copy of which may be obtained from the Planning and Community Development Department.

Following Mr. Baumgartner's presentation, Chairman Lumgair opened the public hearing to afford interested persons the opportunity to be heard or to present written comments concerning the Atlantic Town Center Development Corporation Conditional Rezoning request. Chairman Lumgair read the public hearing guidelines. The following persons signed up or requested to speak:

#### Robert Tittle

Mr. Tittle requested that the Planning Commission not approve the rezoning request and addressed multiple concerns including there not being enough jobs to support development, people are not looking to stay and buy homes here (they come to Wallops, complete their projects, and leave), the possibility that this "experiment" could go wrong, etc.

#### Ronnie Thomas

Mr. Thomas submitted written comments that raised concerns with the application, the possibility of a failed sewer system, proffers, playground, etc. Mr. Thomas requested that the Planning Commission send this rezoning request (and conditional use permit) to the Board with a denial. [A copy of Mr. Thomas's letter may be obtained from the Planning and Community Development Department.]

## Hayden Gordon

Mr. Gordon submitted written comments that asked the Planning Commission to consider multiple points including Wattsville being in close proximity to Wallops; Old Mill Point and Corbin Hall are not built out; Chincoteague Island has motel accommodations, restaurants, and recreation; traffic concerns on Chincoteague Road; people come to Wallops, carry out their projects in a short period of time, and leave to go back home; etc. [A copy of Mr. Gordon's letter may be obtained from the Planning and Community Development Department.]

Chairman Lumgair closed the public hearing.

# **B.** Town Center Utility Facility Conditional Use Permit Amendment

Chairman Lumgair opened the public hearing.

Mr. Morrison presented a PowerPoint presentation on the Town Center Utility Facility Conditional Use Permit Amendment.

Chairman Lumgair opened the floor for the applicant's attorney, Mark Baumgartner, to present if he wished. Mr. Baumgartner did not have a presentation for the Conditional Use Permit Amendment but did question what is being asked of the applicant. Mr. Morrison told Mr. Baumgartner that a site plan depicting the service location needed to be submitted.

Chairman Lumgair opened the public hearing to afford interested persons the opportunity to be heard or to present written comments concerning the Town Center Utility Facility Conditional Use Permit Amendment. The following persons signed up or requested to speak:

#### Robert Tittle

Mr. Tittle addressed concerns such as this affecting the surrounding community, the system possibly failing, taking away from farm land, etc.

Chairman Lumgair closed the public hearing.

Mr. Baumgartner stated that they would proffer as a condition as part of the Conditional Use Permit to add a designation of "Phase I as depicted on Development Exhibit A1" and Phase I will be proffered as the additional capacity area to be used for the development.

The Planning Commission then began its discussion of the two applications and voiced some concerns with the requests such as the need for more information, the need for an economic/market study, many unknowns, previous approval and no work being done, etc.

The Planning Commission requested the applicant to submit a market study and for a projected start-up time (including for the by-right development).

On a motion made by Mr. Roberts and seconded by Mr. Silverman, the Planning Commission voted to defer the Atlantic Town Center Development Corporation Conditional Rezoning and the Town Center Utility Facility Conditional Use Permit Amendment applications until the work session scheduled for Tuesday, September 23, 2014.

## 8. NEW BUSINESS

# A. Modest Town Agricultural and Forestal District Review

Ms. Tremblay presented a brief PowerPoint presentation on the Modest Town Agricultural and Forestal District Review and also pointed out an error in one of the parcels recommended for removal; parcel 56-A-57 (Ruth T. Kellam, Vera T. Brutton et als) should be kept in the Modest Town Agricultural and Forestal District.

On a motion made by Mr. Roberts and seconded by Mr. Picardi, the Planning Commission voted to recommend continuation of the Modest Town Agricultural and Forestal District, with parcels 70-A-114G, 70-A-98E, 70-A-80A, and 79-13-3 being removed from the District and parcel 56-A-57 being kept in the District, to the Board of Supervisors, with Mr. Onley abstaining.

# 9. OTHER MATTERS

Due to the time, other matters were not discussed.
