#### In Re: Call to Order

The Chairman called the meeting to order and indicated that a quorum was present.

#### In Re: Invocation

The invocation was given by Ms. Major.

#### In Re: Statements from the Public

There were no comments.

#### In Re: Account Balances

The monthly Assistant Secretary-Treasurer's report showed an ending balance at December 31<sup>st</sup> of \$19,571.96.

#### In Re: Minutes of December 2, 2014

Motion was made by Mr. Wolff, seconded by Mr. Trala, that minutes of the meeting of December 2, 2014 be approved. All members were present with the exceptions of Mr. Hart and Mr. Hogg and voted "yes". Motion was unanimously passed.

## STAR Transit Management Report January 6, 2015

#### **Operations**

The STAR Transit Manager completed an on/off study on each of the routes individually to determine route optimization. Results from the study will be available at the board meeting.

MyStarTransit.org website is currently down due to a license issue with the originating party who created the website many years ago. We are working with the host site (godaddy) to purchase the existing site and should have update in the next two weeks.

#### **Transit Capital**

No items for discussion

#### **Human Resources**

Transit Manager is actively hiring to fill two vacant driver positions.

#### **Marketing and Outreach**

**Management Outreach** – The STAR Transit Survey regarding public interest in service connecting to VA Beach has completed and results will be handed out at the board meeting (please see attachment).

Based on the results of the survey, Mr. McGregor said that he could not recommend applying for funding during this cycle (applications due 2-1-2015), particularly in light of the hospital's 22-month construction schedule (October 2016). He said that the Transit Development Plan (TDP) indicates that there is a need and/or desire to have a route going across the Bay and at least two buses would be needed to implement this new route. He estimated that \$50,000 in local match, (from both counties in total) would be needed to fund the new route for a year (new route = \$35,000 + capital for two buses).

Mr. Wolff commented that it was possible that citizens from southern Northampton County would choose to go north to seek medical services rather than travel across the Bay and suggested getting input from both boards of supervisors as to whether the counties were amenable to providing the required local match.

Mr. Hart asked why would Accomack County provide funding for a route that takes people away from the County. He said that he would like to see expanded service in Northampton County to serve the southern part of the area which lacks public transit service now. A new route would require approximately \$35,000 in local match. In response, Mr. McGregor noted that if such expanded service in southern Northampton County is allowed in the Transit Development Plan, he can submit an application by the February 1<sup>st</sup> deadline. Mr. Hennessee agreed, noting that an amendment to the TDP can be filed to accompany the funding application if necessary. Motion was so made by Mr. Wolff, seconded by Mr. Trala and unanimously passed. The Commission also directed that staff send letters to Accomack and Northampton County, requesting that letters of support be provided to accompany the grant application.

As a final comment, Mr. McGregor informed the Commission of a charter service called "Virginia Rides", which is affiliated with VRT. Participation in this charter service may be a possibility; the service can be marketed to see if there is enough interest to justify the use.

On December 6, 2014 STAR Transit transported Santa and Elves from Parksley to Cape Charles to catch the Santa Train back to Parksley.

#### **Transit Maintenance**

**Preventive Maintenance Program** - All Star Transit vehicles have been serviced for the month of November and all vehicle maintenance records are up to date.

#### **Ridership Statistics**

*Ridership Statistics* – The December 2014 STAR Transit passenger statistics show over 7,000 rides which is 10% higher than the same month a year ago.

1. We handled 106 carloads in December to bring our 9-month total to 1,326 cars which is 81 cars fewer than last year, but our Revenue per car is greater than last year.






# **Government Support – Star Transit**


# **Passenger Services – Star Transit**

With specific regard to the value of the railroad assets, it was the consensus of the Commission that the \$10.1 million assigned value was appropriate.

Mr. Mitchell also provided a memorandum detailing the problems encountered by his staff when they tried to ride STAR Transit during their visit. Mr. Sims indicated that this situation occurs when there are numerous wheelchair customers. He specifically checked nine bus routes this morning and found that all buses arrived within sixty seconds of the published arrival times.

Motion was made by Mr. Hart, seconded by Ms. Major, that the FY 14 audit report be approved as presented. All members were present and voted "yes." The motion was unanimously passed.
