Operations

- Bus 33 on the Silver route with one passenger on board was struck by a car pulling away from the pumps on the Nelsonia Royal Farms property on Aug 17. Damage to the bus was mostly cosmetic and the bus remains in service. The car sustained minor damage. The one passenger said she was not hurt; left the scene of the accident but later declared she was seeking medical care. Our insurance company is handling the claim. Our bus driver and the driver of the car were not injured.
- Proposed YELLOW expansion route is attached for viewing and comment. *It was noted that the community of Fairview is being added to the proposed route.*
- STAR Transit was advised by DRPT that there were no findings on the recent audit (email attached).

- VDRPT has given their approval to STAR to use the insurance money from bus 230 towards the purchase of a new 12 passenger bus. The insurance money will cover the entire cost of the new bus.

In Re: Closed Session

In Re: Airport Update

Mr. Wolff noted that everything on the Wallops launch pad should be completed by the end of this month and anticipates a launch sometime in the March-April 2016 timeframe.

In Re: Railroad Comments

Mr. Parry presented the following report:

ANTDC MEETING Sept. 1, 2015

- 1. In August, BCR handled 433 carloads. 375 of these were at Little Creek with the top shippers being, 40 for Mid-Atlantic Transload (grit), 19 for Gordon Paper, 20 for Koch Nitrogen (Storage) and 296 handled for DCP Midstream (Butane Storage). Eastern Shore location handled the remaining 58 loads with the top shippers being Bayshore Concrete Products 25 cars. Associated Grain 14 cars and Coastline Chemical 8 cars.
- 2. Installation of new crossing for Ingleside Road has been completed and phone calls have been received from citizens expressing gratitude for the new installation. A much smoother ride by automobile has been noticed and appreciated. Azalea Garden Road new crossing has also been completed.
- 3. New gates/signals are being planned for Route 622 Treherneville.
