### **Call to Order**

The meeting was called to order by the Chair Ron Wolff, and open with a prayer by Ms. Major, after which the Pledge of Allegiance to the Flag was recited.

### **Discussion on Poultry Houses**

Mr. Rich Morrison, Planning and Community Development Director gave a brief presentation on poultry houses. He told the Board the current ordinance for poultry houses included no density requirements and no limit of houses.

He said the proposal called for a 500-foot setback from existing dwellings and 600 feet on sides with tunnel fans and that in agricultural, general business and residential zones, the setback from incorporated towns or residential zoning district boundaries or subdivision of 10 or more lots would go from 400 to 500 feet, with 600 feet on sides with tunnel fans.

He reviewed additional amendments for consideration and responded to questions

Supervisor Harrison Phillips said he would like setbacks from churches, daycares, recreation centers, nursing homes and similar properties to be measured 500 feet from property lines.

Mr. Morrison recommended the supervisors move forward with the proposal and later include an amendment for those stipulations because it would have to go back to the Planning Commission.

Mr. Crockett made a motion to schedule a Public Hearing to afford interested persons the opportunity to be heard or to present written comments concerning proposed amendments to Chapter 106, Zoning, Article X, Section 102-232, Poultry, of the Code of

the County of Accomack, Virginia on Wednesday, February 3, 2016 at 7:30p.m.in the Cafetorium of Metompkin Elementary School. Mrs. Gordy seconded the motion.

A discussion ensued concerning changing the time of the Public Hearing to 6:00p.m.

Mr. Crockett restated his motion to schedule a Public Hearing to afford interested persons the opportunity to be heard or to present written comments concerning proposed amendments to Chapter 106, Zoning, Article X, Section 102-232, Poultry, of the Code of the County of Accomack, Virginia on February 3, 2016 at 6:00p.m. in the Cafetorium of Metompkin Elementary School in Parksley, Virginia. The motion was unanimously approved.

### **Adjournment**

Mr. Crockett made a motion to adjourn. Ms. Major seconded the motion. The motion was unanimously approved. The meeting adjourned at 5:45 p.m.
