Ms. Milbourne stated that all adjoining property owners disapproved with the exception of Mrs. Wiggins.

Mrs. Debbie Thornton and Mrs. Jennifer O'Brien were present and spoke in opposition of it as they had several concerns which were what exactly the business would be and sell, the hours of business, the traffic, and the use of their right-of-way.

After a lengthy discussion, Mr. Gayle made a motion to table this application until additional information regarding the following was obtained:

- 1.) The intended business use as it pertains to the products for sale;
- 2.) VDOT approval for the enterance(s) off Lankford Highway;
- 3.) Signage for the business; and
- 4.) Solution to the concerns of the neighbors.
