Petition for Writ of Election

County Attorney Cela Burge advised the Board of the recent letter received from

Commonwealth Attorney Gary Agar submitting his resignation effective September 2, 2016,

stating that he will be retiring. She referred to the provision of Code which provided a

mechanism wherein a Constitutional Officer resigns, there is a specific procedure to be followed.

She stated the procedure was to have the Board of Supervisors petition the Circuit Court for a

Writ of Election.

She requested that the Board adopt a prepared resolution to that affect which would allow for a Special Election to fill the unexpired term of Gary Agar as Commonwealth's Attorney

during the General Election on November 8, 2016. A discussion continued.

Mr. Crockett made a motion to adopt the following Resolution of the Board of Supervisors of Accomack County, Virginia, relative to the resignation of the Commonwealth Attorney, Gary R. Agar. Mr. Phillips seconded the motion. The motion was unanimously approved.

RESOLUTION OF THE BOARD OF SUPERVISORS OF ACCOMACK COUNTY, VIRGINIA, RELATIVE TO THE RESIGNATION OF THE COMMONWEALTH ATTORNEY, GARY R. AGAR

WHEREAS, the Board of Supervisors of Accomack County has been notified that the Commonwealth Attorney, Gary R. Agar, has resigned, effective September 2, 2016; and

WHEREAS, a Petition and Writ must be filed in the Circuit Court of Accomack County, Virginia, and the Petition must be accompanied by a Resolution of this Board; and

WHEREAS, the Accomack County Board of Supervisors finds that an emergency exists for a Writ to be Ordered in time to meet certain deadline requirements; and

WHEREAS, the citizens of Accomack County should enjoy the earliest opportunity to elect a new Commonwealth Attorney and a Special Election held on a short interval would ensure continuity in the office of the Commonwealth Attorney, which is responsible for the prosecution of crimes committed in Accomack County; and

WHEREAS, the Board of Supervisors of Accomack County, Virginia, deems it necessary to enact this Resolution so that all deadlines for an election of a new Commonwealth Attorney may be held at the General Election to be held on Tuesday, November 8, 2016.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF ACCOMACK COUNTY, VIRGINIA, that due to the resignation of the Commonwealth Attorney, Gary R.
