# STAR Transit Management Report August 2, 2016

## **Operations**

- On July 22, Purple Route bus 29 while stopped at a stop sign at Brickhouse Rd. and 13, was struck in the driver's side by a passenger vehicle which itself had been hit in the rear by another vehicle with an unlicensed driver in an uninsured vehicle:
  - One of the 4 passengers on our vehicle was hurt: taken to the hospital and discharged late that evening.
  - o Bus 29 appears at the present time to be drivable yet will need body work before being returned to service.
  - o The driver of the uninsured vehicle was charged with failure to yield.
- Nelsonia Royal Farms is now open and functioning again as our mini-hub.
- Buses 32 and 33 each now carry a small Va. Lottery ad that will be generating 750 dollars a month in additional income.

### **Human Resources**

• Staffing levels are now adequate after hiring one more part time driver.

- Attended the Riverside Shore Hospital CHNA Focus Group meeting on July 21.
- Purdue HR recently asked us about extending our service hours of operation to accommodate their 2<sup>nd</sup> shift employee commute.
  - o A meeting with them is being planned.
- Met with Sunset Beach resort on July 23.

### **Transit Maintenance**

- Preventive Maintenance Program
  - o Routine vehicle preventive maintenance is up to date.
- Buses Under Repair:
  - o Bus 28 is still at Sonny Merriman repair facility in Suffolk- should be ready in 2 weeks.
  - O Bus 29 is out due to accident on July 22- awaiting Insurance settlement for repairs.

### In Re: Railroad Comments

The following report was presented:

In July 2016, BCR handled 284 carloads. 264 of these were at Little Creek with the top shippers being:

40 for Mid-Atlantic Transload (grit),12 for Gordon Paper,5 for Dynaric, and207 DCP (Gas Supply –Butane cars).

Eastern Shore location handled the remaining 20 loads with the top shippers being:

Bayshore Concrete 5 inbound cars and 5 outbound cars, Coastline Chemical 3 inbound cars, Pep Up Gas 4 inbound cars, 2 cars for KMX Chemical, and 1 inbound hi-wide load (transformer).

Mr. Parry reported on the storm last Sunday evening which caused damage at the Little Creek float bridge location. Seven inches of rain and 60-mph winds caused a major washout, undermining the float bridge. He is working with the neighbor, Vulcan Materials.
