# C. National Business Aviation Association (NBAA) Trade Show – Regional Forum Information

Mr. Seybolt reported that he attended the poverty meeting at the Workforce Development Center. He also reported that 53% of senators/delegates are not born in Virginia and therefore are not familiar with many areas of the state. A report was also given on the drug epidemic.

Mr. Davis also attended the poverty meeting and found it to be an instance of reporting a significant number of statistics, which demonstrated dire straits. Mr. Davis expressed concern that it was never linked together to find the underlying cause.
