## **Operations**

- The Lower Shore Community will now have more opportunities to shop and work following a meeting by STAR Management with the supervisory staff of the new Cape Charles Royal Farms and the adjacent Kiptopeke Inn that resulted in a new combined "will call" WC stop on the Yellow route.
- Another new bus ad (Heritage Hall) will be placed on the Green route bus Nov. 3.
- Fiscal YR 2017 ridership at 93,787 was a 6,278, 7% increase over 2016 with 87,509 rides. The Yellow route showed the greatest growth at 43% a 2,498 increase from the prior year.

• With the recent addition of one more driver, the STAR Management Team has brought the driver workforce up to desired operating levels.

## **Capital**

- Thanks to the efforts of the VRT Management Team, additional funding has been acquired for 2 new STAR buses and a van with an expected delivery date around the second quarter in 2018.
- The STAR Facility painting has been completed. The new egg shell paint with added mold inhibitor will make wall cleaning and maintenance much easier for the STAR staff.
- The four buses that were retired when the new ones arrived are currently being prepped at the STAR Facility for an on line auctioning at "Public Surplus: Government Surplus Auctions" *publicsurplus.com*.

## **Marketing and Outreach**

- The Cheriton Migrant Worker Head Start field trips on the STAR routes, ending with the last one of the season on Oct. 13 to Kiptopeke State Park, were such a success that they will occur again next summer according to the organizer Max Lozinda, USFW Park Ranger. An article about the program appeared in the *Post*.
- STAR Management, working with the Eastern Shore Independent Living Center to celebrate Disability Awareness Month, provided rides for their clients to the ESIL showcase event at Nandua HS on Oct. 14.
- STAR Management attended the quarterly Eastern Shore Disaster Preparedness Coalition (ESDPC) on Oct 25. In the in event of a major emergency, Community Transportation will play a vital role in getting the general population to local preplanned stations there to be evacuated by a State-contracted entity.
- As part of an initiative to introduce young riders to public transit, STAR Transit Management provided free rides on the Green Route Oct. 26 for an Onley Preschool field trip to the Hermitage Retirement Home in Onancock.

Mr. Wolff said that the next Antares launch is scheduled for this coming Saturday morning.

## In Re: Railroad Comments

The following report was presented:

In October, Bay Coast Railroad handled 73 carloads. 48 of these were at Little Creek with the top shippers being:

3 for Dynaric,26 for Mid-Atlantic Transload (grit),

19 for Gordon Paper.

Eastern Shore location handled the remaining 25 loads with the top shippers being:

Coastline Chemical 10 cars, KMX Chemical 2 cars, Pep Up Gas 9 Cars and Helena Chemical 2 cars.

Mr. Parry reported that the DCP traffic (butane) has been lost from the Little Creek side; however, he is hopeful that other new traffic will be realized to fill the void. Sadly, there will be no "Santa Train" running this year due to the poor condition of the passenger-car. There are discussions being held relative to using local fire trucks instead of the train.

#### <u>In Re: Closed Session:</u>

Vehicular accident involving STAR Transit vehicle

All members were present with the exception of Mr. Hogg and voted "yes." The motion was unanimously passed.

After Closed Session, the Chairman reconvened the meeting and said that the Commission had entered the closed session for those purposes as set out in paragraphs 1 and 7 of Section 2.1-3711 of the Code of Virginia of 1950, as amended. Upon being polled individually, each member confirmed that these were the only matters of discussion during the closed session.
