Ms. Wheatley reported on the proposed traffic signal at the intersection of Parkway and Rt. 13. VDOT update: The project is currently going through scoping and site survey. Funding has been accelerated and we anticipate construction sometime in 2018. As the project progresses, a more definitive timeline will be created.

9. NEW BUSINESS

A. Taylor Property 101-5-A16

The owners of parcel 101-5-A16, having listed the property for sale, received a viable contract from Franklin Mechanical Contractors, Inc. According with the Accomack Airport Industrial Park covenants section 17, the EDA is required to vote on exercising the option to repurchase real estate prior to transfer of ownership. After discussion and correspondence from the prospective owner dated 11/6/17 was read, a motion was made by Mr. Edwards and seconded by Mr. Seybolt stating the EDA does not desire to exercise its option to repurchase the property as outlined in Section 17 of the covenants.
